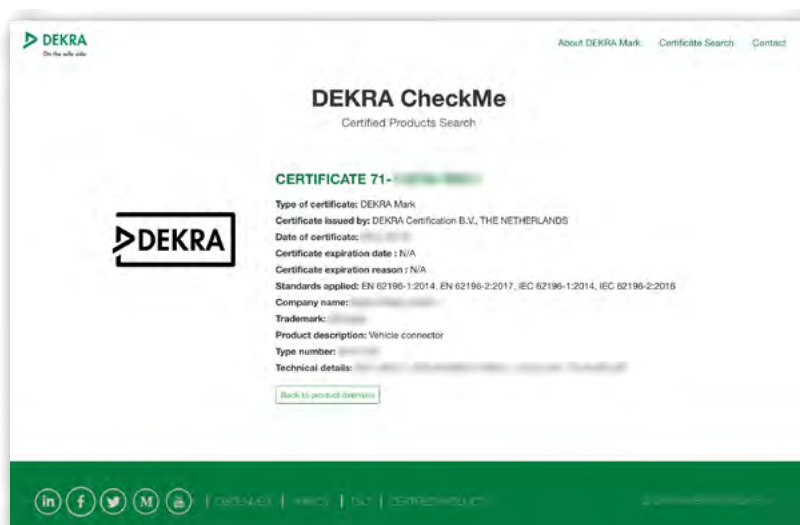
Benefits of DEKRA Mark
