Background

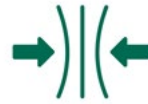
To secure the operations of a Supply Chain, it is mandatory to cover both governance and resilience topics. Based on the results, it appears that you have marked governance topics ("G"), resilience topics ("R"), and holistic supply chain topics ("S") with "NO," indicating areas that require immediate attention.



Supply Chain Governance

This involves compliance with national laws, such as Germany's LkSG (Supply Chain Due Diligence Act), or similar legislation in countries like France, the United Kingdom, Norway, Switzerland, the USA, Australia, and others. These laws cover issues such as human rights (e.g., slavery, child-labor, labor rights requiring companies to integrate these concerns into their corporate philosophy, conduct risk assessments of human rights violations within their inbound supply chain, develop contingency plans to avoid non-compliant suppliers, and regularly report these measures to stakeholders and authorities.

Additionally, the Commission of the European Union has introduced the EU-wide "Corporate Sustainability Due Diligence Directive" (CS3D), which mandates these regulations and requires a climate change mitigation transition plan aligned with the 2050 climate neutrality goal of the Paris Agreement for all EU member states.



Supply Chain Resilience

Resilience issues are factors that can disrupt the supply chain either immediately or gradually. Risks include financial instability of suppliers, operational or cyber disruptions, and geopolitical tensions. Unlike governance issues, the analysis of these risks is not required by law and must be managed through the company's own initiatives and responsibilities.
