From the DOW onwards, any product falling into the scope of the relevant safety Directive should comply with the new amendment / edition of standard for DEKRA certification.

We would like to remind you that your products, which have already been certified by DEKRA without the consideration of the above Directive but they would still be available from the market after the corresponding DOW, should be resent to the respective DEKRA laboratory, in order to make sure that your product meets the requirement of new Directive.
