What the GMP+ standard represents

The GMP+ module Feed Safety Assurance Scheme (FSA) is an international certification system to ensure the safety of animal feed. It covers all stages of the feed production chain, from the cultivation of raw materials, the production of compound and straight feed stuffs, additives and premixes to trade, storage and transport. The Feed Responsibility Assurance (FRA) module focuses on sustainable feed.

Goals of the GMP+ standard

With the introduction of the GMP+ standard, you

- Ensure the traceability of your goods and maintain a complete overview of the preliminary and by-products used;
- Send a signal that you are aware of your responsibility for food and feed safety;
- Provide your company with access to global markets and credibly demonstrate your commitment to food safety and sustainability.
