The aim of the CRITIS audit

Critical infrastructures (CRITIS) are organizations and facilities that are of vital importance to the state community and whose failure or impairment would result in long-lasting supply bottlenecks, significant disruptions to public safety, or other dramatic consequences. Based on the German IT Security Act Version 2.0 (IT-SiG 2.0), which was amended in 2021, the German CRITIS Regulation (KritisV) was also expanded. CRITIS operators are now required to demonstrate compliance with the requirements contained therein to the BSI every two years.

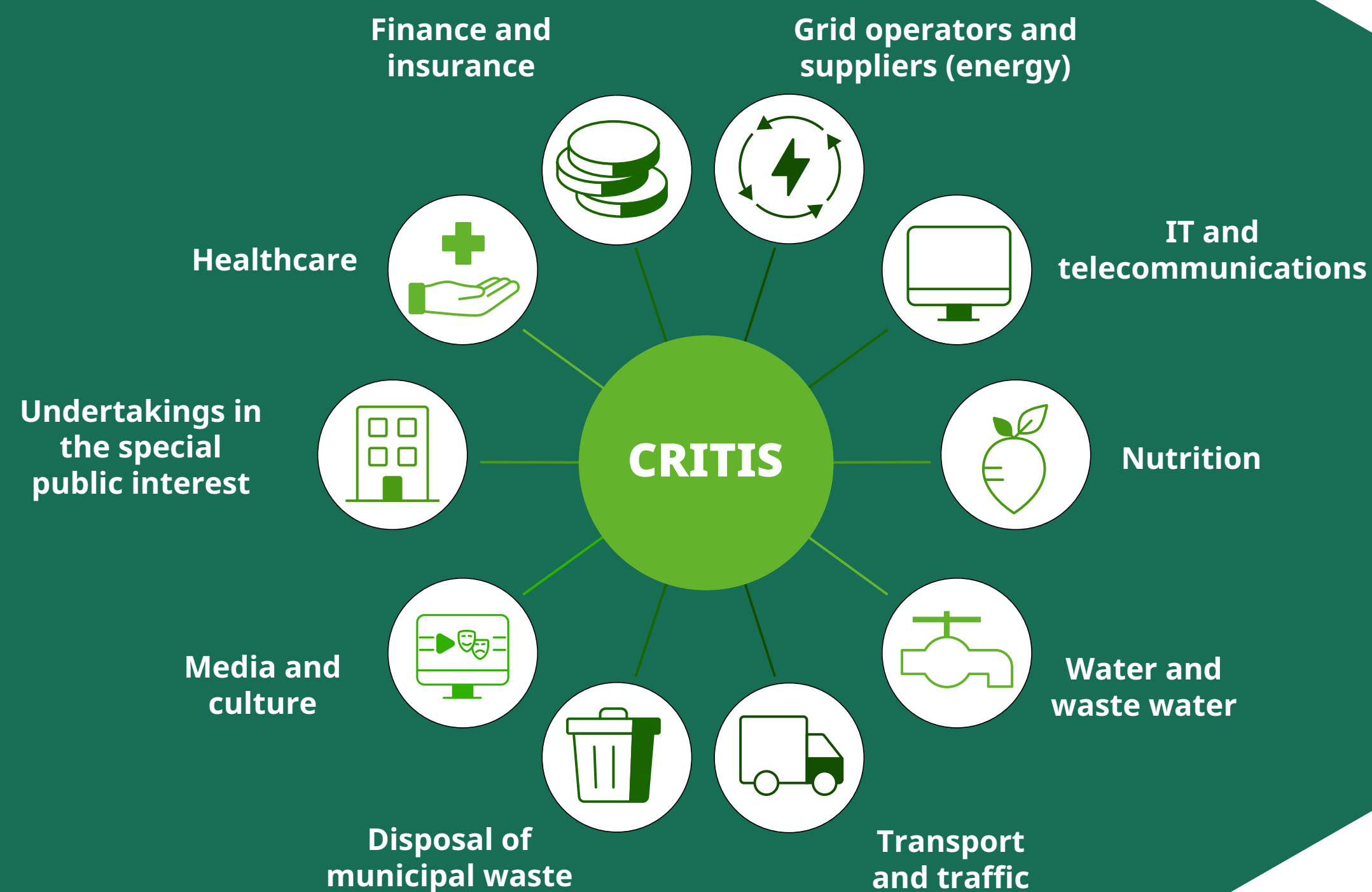
