## 1. Scope

These Examination and Certification Regulations (PZO) apply to all certification procedures for SCC personnel in accordance with the program for the certification of persons of DEKRA Certification GmbH (DCG). Examinations based on the SCC Personnel Examination Program VAZ 2021 and DIN EN ISO 17024 in the respective valid versions lead to the DAkKS accredited SCC degrees (Safety Certificate Contractors):

- SCC Operational employees according to document 018
- SCC Operational supervisors according to document 017

In addition, the General Terms and Conditions (GTC) (D-030-18) and the General Certification Conditions (GTC) (D-030-19) of ~~DEG~~ DEKRA Certification apply.

The services of the certification body are open to all interested persons and the ~~DEG~~ DEKRA Certification guarantees equal treatment of all applicants by setting objective criteria for admission, examination and certification.

## 2. Application and admission to the examination

The application for an examination and certification is made in writing on the basis of the application for certification as SCC personnel (F-03S-22) and confirmation of the PZO, AZB and AGB of the ~~DEG~~ DEKRA Certification. The application must be submitted at least 10 working days before the scheduled examination date.

Participation in the examinations mentioned under point 1 is subject to the admission requirements listed accordingly in Annex 1.

The evidence required in Annex 1 must be enclosed with the application for certification. The burden of proof lies with the person to be audited.

If the admission requirements are not met, the person to be examined will be excluded from the examination. ~~or will take the examination and submit the missing evidence within 10 working days. If the admission~~

~~requirements have not been fulfilled within 10 working days of the examination date, an examination that has been taken will be deemed to have been failed without further ado and the examination fee must be paid in full. In the event of ambiguities, the certification office is entitled to request further evidence.~~

All certificates must be written in German. Foreign certificates must be translated by the applicant via a publicly appointed and sworn translator.

The certification body checks the completeness and formal correctness of the application documents as well as the fulfilment of the admission requirements and decides on the admission to the examination.

### 3. Conduct of the examination

The examination is written and consists of multiple-choice questions (MCF), which are compiled by the certification body according to the specifications of the SHE-Personal VAZ 2021 program and using the current SHE examination question catalogue. Each questionnaire may only be used once.

The examination is generally held in German.

The organization of the examination is the responsibility of the certification body. The examinations are carried out by approved examiners commissioned by the ~~DCG~~ DEKRA Certification for this purpose or by an examination supervisor. The performance of the examination on site is the responsibility of the appointed examiner / examination supervisor.

#### 3.1. Performance of the SCC examination according to doc. 018

The examination is written and consists of 40 MCF. The duration of the examination is 60 minutes. The maximum possible score is 40 points.

No aids are permitted.

#### 3.2. Performance of the SCC examination according to doc. 017

The examination is written and consists of 70 MCF. The duration of the examination is 105 minutes. The maximum possible score is 70 points.

No aids are permitted.

### 4. Exam results analysis

The ~~determination of the examination result~~ is carried out by the appointed and approved examiner.

The examination is considered passed if at least 70 % of the possible maximum number of points is achieved. If less than 70 % is achieved, the examination is considered failed.

The examination result and the examination documents are sent to the certification body and cross-checked.

### 5. Certification decision

Based on the admission documents and the examination result, DEKRA Certification makes the certification decision within approximately four weeks following the examination date. If the certification body's ~~decision deviates from the examiner's recommendation~~, this must be justified in writing.

If the examination is passed and certification is successful, the DEKRA certificate is ~~usually~~ issued in German and English for a maximum period of 5 years. The certificate contains the following information: full name, date of birth and title (if available) of the certified person, the acquired qualification level, DEKRA logo, DEKRA mark, information on the certification body, date of examination, place of examination, date of issue, place of issue, expiry date of the certificate, unique certificate number, the SCC logo, the logo of the German Accreditation Body (DAkkS) and the signature of the responsible person.

The certificate holders shall be included in the list of certified persons of the ~~DCG~~ DEKRA Certification intended for publication for authorized persons. The certificate remains the property of DCG. The terms of use for the certificate are regulated in the GTC.

### 6. Repetition of the examination

A failed examination can be repeated as often as desired. The application for a repeat examination is made in writing on the basis of the application for repeat examination (F-03S-09) and confirmation of the PZO, AZB and AGB of the **DEG DEKRA Certification**.

### 7. Surveillance

The certified person is responsible for ensuring that he or she retains his or her competence. For this purpose, a code of conduct is agreed upon the certified person ensures, among other things, regular participation in the employer's occupational health and safety instructions (at least annually in accordance with ArbSchG § 12 in conjunction with DGUV Regulation 1, § 4) as well as obligatory protection of the environment and safe working. **DEG DEKRA Certification** monitors compliance with the terms of use for the certificate. This includes - if occurring during the validity period of the certificate - the evaluation of information from supervisory authorities, the evaluation of complaints and information from interested parties as well as legal actions initiated with regard to the certified person.

### 8. Recertification

Certificate holders may apply for recertification in writing to **DEG DEKRA Certification** during the validity period of the current certificate, using the recertification application form (F-03S-65).

The following proofs required in Annex 1 must be submitted with the application.

Applications submitted later will not be accepted

The prerequisites for recertification are a complete and correct application, the positive evaluation of the submitted evidence and the successful completion of a new audit within 3 months after the expiry of the validity of the old certificate in accordance with point 3. In case of successful recertification, a new certificate will be issued for another max. 5 years. The previous certificate loses its validity.

### 9. Examination documents

All documents relating to the examination are archived electronically by the certification body. The retention period is 10 years.

<b>Re-certification</b>	Persons holding a still valid SCC certificate according to doc. 017 or doc. 018*. <b>*In exceptional cases, the re-examination may take place within 3 months of the expiry of the old certificate.</b>	Copy of the still valid <b>SCC certificate</b> according to SCC doc. 017 or doc. 018.  The certificate must have been issued by a recognized body (under German accreditation).

### Please be sure to observe the following instructions:

- All evidence submitted must be written in German. Foreign certificates must be translated by the applicant via a publicly appointed and sworn translator.
- The certificates must be complete and legible. If the certificates consist of several pages, all pages of the certificate must be submitted.
- Copies of the certificates must be submitted.
- The contents of the training must relate to German (occupational health and safety) law. Shortened SCC training courses (e.g. 8 instead of 24 LE.) can replace missing professional experience in Germany after individual assessment. The decision on this is made by DEKRA Certification GmbH.
- Training can only be carried out by recognized training service providers/lecturers qualified in the HSE sector. **The admission of training providers and instructors qualified in the HSE field as education partners is determined by DEKRA Certification GmbH.**
- A teaching unit (LE.) corresponds to a teaching unit of 45 minutes.
- The DEKRA **Certification** form "Training certificate SCC personnel" (F-03S-32) in the current version must be used in all cases. Other training certificates are not accepted. The personal training certificates are valid for ~~40~~ 5 years.
- In order to fulfil the admission requirements according to option 3, already existing certificates of employment can also be recognized if they contain the mentioned points. Work experience in Germany must be explicitly confirmed. Professional experience abroad cannot be recognized. The proof must include the period of professional experience.
