The establishment of a food safety management system in accordance with ISO 22000 is done largely along the same lines as the well-known ISO 9001 and ISO 14001 standards. This makes it much easier for certified companies to fulfill their legal obligations in the area of product liability (organization, selection, control, documentation and due diligence).

Benefits of food certification

A consistently applied quality management system helps you to recognize potential risks at an early stage and to avoid them on a systematic basis. To this end, ISO 22000 offers you a uniform and comprehensive quality standard for all of the processes associated with food and animal feed.

The globally recognized food certification also provides you effectively reduce liability risks. The high degree of compatibility with other management standards such as ISO 9001, ISO 14001 and ISO 45001/ BS OHSAS 18001 also reduces the documentation and certification effort when integrated into existing management systems.



Steps for your successful certification

1. Information meeting

- Clarification of outstanding issues
- Joint determination of the next steps
- Project discussion

2. Documents review and on-site audit

- ▶ Readiness analysis
- Description of your management system
- Proof of your quality capability towards your customers
- Implementation of the documented statements in daily business

3. An audit report that includes:

- ▶ Results of our assessment
- In the case of discrepancies, recommendations for potential optimizations and post-evaluation

4. Test seal and certificate

- Issuing of the certificate after successful completion of the certification process
- Issuing of the test seal for the duration of validity of your certificate: three years

This is followed by annual surveillance audits to verify the continued existence and development of your management system.
