Occupational health and safety according to ISO 45001

Safe and healthy workplaces are the key to high-performing companies. Modern occupational health and safety goes far beyond straightforward accident prevention and takes a holistic preventive approach. In this respect, all risks, from physical and mental health problems arising at work, through to incapacity for work and the inability to work are to be taken into account. The ISO standard 45001 is the only independent international standard to define the requirements of an occupational health and safety management system. With certification from DEKRA, you achieve a safe and healthy organizational culture.

What ISO 45001 stands for

With its risk-based approach, this standard provides the basis for an all-around healthy organizational culture. The conditions throughout the supply chain are considered in order to prevent as far as possible work-related injuries, illnesses and stress factors that pose a risk to health.

The scope of application encompasses all types of organizations that extend beyond sole proprietorships. It therefore includes organizations that have multiple locations and work with multiple contractors, subcontractors, suppliers or temporary workers.

Objectives of ISO 45001

The objectives of **ISO 45001** in the field of occupational health and safety are identical to those of the previous standard, BS OHSAS 18001. The standard was developed to bring together all of the national and international occupational health and safety management systems in a single standard.

The focus is on preventing incorrect behavior in the organization which can lead to occupational accidents and on reducing downtimes caused by accidents in the organization's supply chain and supplier management.

Steps for your successful certification

1. Information

Project Meeting (by phone or in person) and preparation for certification, including review of documentation

2. On-site certification

Readiness analysis with assessment and review of the description of the management system, review of documented processes and optional post-audit (review of corrective measures)

3. Audit report and assessment

Documentation of the audit and assessment of the management system

4. Certificate and seal

After successfully completing the certification, you will receive your certificate and the DEKRA certification seal (with a maximum validity period of three years)

5. First surveillance audit

A surveillance audit of the practical implementation takes place every 12 months

6. Second surveillance audit

Repeated auditing of the practical implementation of the management system

7. Recertification

Steps 2 to 6 are repeated in the recertification audit three years after initial certification
