Verification according to the criteria of the Safety Quality Assessment System (SQAS) enables you to ensure the corresponding protection and safety. SQAS provides transport operators with a monitoring element that enables them to carry out a uniform assessment and monitoring of their services.

The European Chemical Industry Council (CEFIC) originally developed these systems for the assessment of safety and quality in the early 1990s. With the help of these standardized assessment procedures and the globally recognized SQAS seal, logistics service providers in the area of hazardous goods are able to document their safety during their transport operations to the outside world.

2. On-site assessment

Assessment according to the SQAS guidelines and questionnaire

3. Assessment report and evaluation

Evaluation of the results, possibly with presentation of potential optimizations, report for the CEFIC-SQAS database


4. Attestation and SQAS logo

No certificate is issued after the SQAS assessment; you will receive the attestation and logo from the SQAS database; the assessment results are available online

5. Recertification

Repeat assessment a maximum of three years later


