

Office Evacuation Procedure

Evacuation alarm

The building has horns and automatic alarms located on all floors, elevator hall and subway level, which will be activated and warn of the activation of the emergency and evacuation plan.

This alarm can be activated by fire, earthquake, bomb threat, among other emergency situations.




General recommendations


- 1. Remain calm at all times, thus avoiding the possibility of collective panic.
- 2. Do not run, movements should be fast and silent.
- 3. In case of evacuation, it should not be returned for any reason.
- 4. In case of smoke, stay low.
- 5. Cover mouth and nose with a cloth if you have to cross a smoke-filled space.
- 6. In the event of an earthquake you **MUST** remain calm, move away from glass, heavy objects and items that may fall on you and wait for the instructions of the Emergency/Evacuation Leaders.
- 7. Follow the instructions of the Emergency/Evacuation Leaders, do not act at your own risk.
- 8. Proceed to the assigned meeting point, do not stay anywhere else.

Emergency on another floor of the building

- Upon activation of the emergency horn, all building occupants should immediately cease their activities and listen for information over the building's audio system or directions from floor emergency leaders.
- 2. Once the emergency has been declared, the evacuation will begin and will be guided by the building's security team through the loud speaker system.
- 3. The evacuation route, from all levels, will be through the doors marked "EMERGENCY EXIT" towards the interior stairwell, heading towards the second floor, leaving through the main hall, towards the exit doors of the building, along the public sidewalk towards the security zone (located at Av. Apoquindo 4700).
- 4. In the event of large earthquakes and/or in the event that there is a risk of falling elements in the main hall of the building, it cannot be used as a meeting point and/or exit to the safety zone, and an alternative evacuation route* must be used.

Emergency at DEKRA offices



- Upon activation of the fire alarm, all building occupants should immediately stop their activities and listen to the information provided by the Emergency/Evacuation floor Leader.
- The evacuation will be directed by the DEKRA
 Emergency/Evacuation floor Leader who will be in a reflective vest for easy identification.
- 3. You should then continue with points 3 and 4 of the emergency evacuation procedure on another floor of the building.

*Alternative evacuation route

If it is impossible to use the exit from the main access, due to detachment of glass, coatings or any other cause, an **alternative escape** route is established through the -1 subway; making a route through the parking lot and exiting through the vehicular ramp towards 90 Orinoco Street, in the direction of the exterior Security Zone.
