

# FAQ - Certification According to ISO 45001

## 1. What is ISO 45001?

The ISO 45001 standard is the first international standard for occupational health and safety management systems (OHSMS). The new standard is intended to ensure uniform improvement of national and international occupational health and safety performance. ISO 45001 was developed based on the standard OHSAS 18001, which it is now replacing, and features a Plan-Do-Check-Act (PDCA) model. The use of the PDCA cycle promotes continuous improvement in OHSMS.

## 2. When did ISO 45001 come into force?

On March 12, 2018, the new standard ISO 45001:2018 was

finally published by the International Organization for Standardization (ISO).

## 3. Which companies should be certified according to ISO 45001?

The certification of occupational health and safety management is suitable for every company, regardless of size or industry. It helps companies ensure the long-term safety and health of their employees and at the same time reach their business goals.

Companies already certified according to OHSAS 18001 are required to transition to ISO 45001 by March 2021.

- You increase the performance and motivation of your employees by providing a safe and healthy workplace.

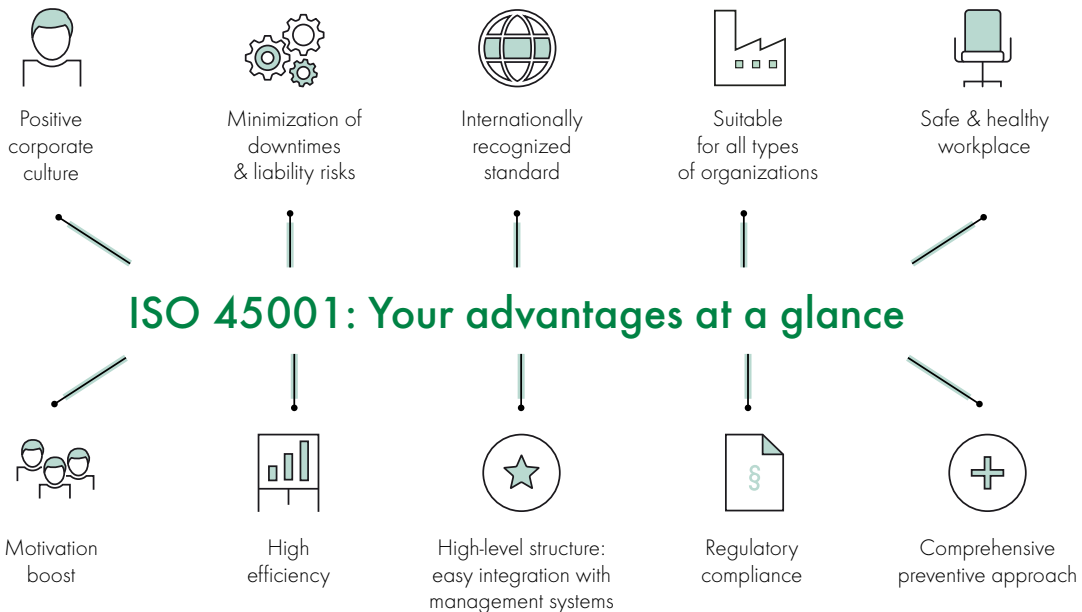
#### 5. What is the ISO 45001 certification procedure?

We certify occupational health and safety in your company in just a few steps:

1. Information meeting and pre-audit (optional)
2. On-site certification
3. Audit report and evaluation
4. Certificate and DEKRA seal of approval
5. First surveillance audit (after 12 months)
6. Second surveillance audit (after another 12 months)
7. Recertification (three years after initial certification)

#### 6. Which standards are suitable for combined certifications?

With its uniform High-Level Structure (HLS), shared by all new and revised management system standards, ISO 45001 can be easily combined with other ISO standards for management systems. For example, ISO 9001 for quality management, ISO 50001 for energy management or ISO 14001 for environmental management.
