## When Safety Teams Talk Practical Moves That Help EHS and Process Safety Operate as One

#### Your Calendar is Full. Your Inbox is Fuller.

Before 10 a.m., you've already fielded inspection findings, contractor questions, incident reviews, and engineering updates. The challenge isn't a lack of effort — it's the friction caused by duplication.

- EHS handles training schedules, compliance reports, and daily employee concerns
- Process Safety focuses on PHAs, safeguard checks, and technical reviews that demand precision
- Both functions are critical. Both are overloaded.
   And too often, both are moving in parallel instead of together

#### Where the Split Becomes Visible

#### **Moves You Can Make Right Now**

**Four Practical Ways to Unify Safety Functions Without Adding Complexity** 

#### 1. Centralize the Data Stream

Consolidate exposure observations, near-miss data, and process hazard findings into a unified dashboard or periodic review. When risk signals coexist, weak signals become early warnings.

- **2.** Establish a Common Definition of "Critical" Align thresholds between EHS and Process Safety for escalation and risk ranking. Shared criteria drive shared urgency and consistent action.
- 3. Audit for Retention, Not Completion
  Closing a finding isn't success; sustained
  behavioral or procedural change is. Track
  rechecks, safeguard verification cycles, and how
  often key learnings reappear in routine
  discussions. Continuity checks reveal whether
  safety is truly embedded.

#### 4. Lead Jointly from the Floor

Integration is visible when leaders are. Joint walkthroughs by EHS and Process Safety reinforce alignment and build confidence across teams. Every shared observation says, "We're in this together."
