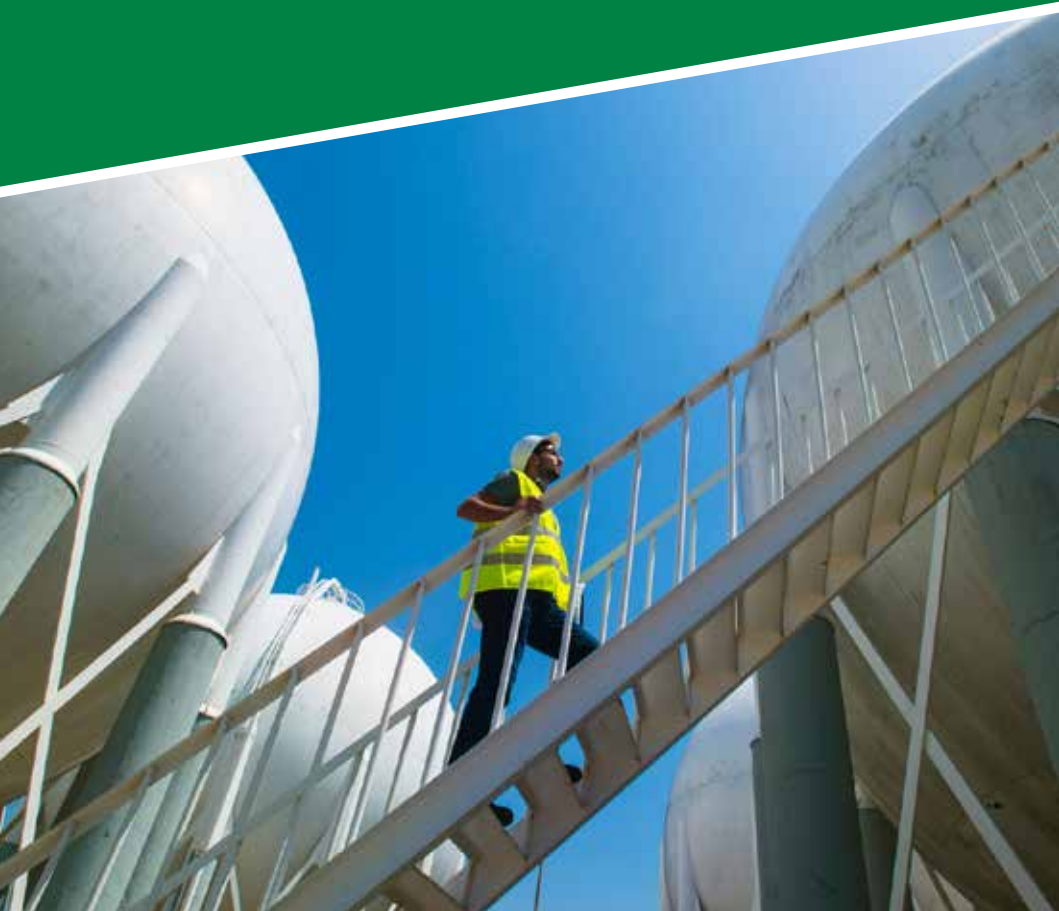
The certification is issued following the preparation of a specific Certification Scheme for a professional figure. The scheme contains both the elements relating to the certification process and the requisites that the professional must possess in order to be considered suitable to carry out his / her activity.

DEKRA operates in this sector as a **third-party Certification Body** accredited in accordance with the UNI CEI EN ISO / IEC 17024 Standard, which prescribes the requirements that a Certification Body must possess to carry out its activities in the context of the certification of skills.

WELDING AND BRAZING STAFF

PERSONNEL IN CHARGE OF SURVEILLANCE OF NATURAL GAS DISTRIBUTION PLANTS

The skills of the personnel operating in the natural gas distribution services are subject to **specific regulations regarding the safety of systems**, appliances and the use of gas, according to UNI 11632: 2016 and related UNI PDR 39: 2018.

The surveillance of distribution systems is essential for safety purposes, as well as the competence of the staff plays a key role in the effectiveness of the interventions. The activity can be carried out by employees of companies that:

- carry out their own activities (typically companies engaged in the distribution of natural gas pursuant to Legislative Decree 164/2000)
- operate on behalf of third parties (typically companies that operate on behalf of companies engaged in the distribution of natural gas)

The UNI 11632 standard defines the knowledge and the skills requirements of the Professional Roles assigned to the field surveillance activities on natural gas distribution systems and applies to personnel who carry out surveillance activities on:

- reception and first reduction of natural gas (REMI or City Gate)
- odorization of natural gas
- reduction of pressure belonging to the gas distribution network

The UNI 11632 standard defines the knowledge, skill and competence requirements of the professional figures assigned to the field surveillance activities on natural gas distribution systems and applies to personnel who carry out surveillance activities on:

- reception and first reduction of natural gas (REMI or City Gate)
- odorization of natural gas
- reduction of pressure belonging to the gas distribution network

DEKRA supports your professionals, **preparing them to obtain the certification** for all four specialist profiles required by the standard:

- **TYPE I** - Person in charge of first installation checks
- **TYPE II** - Person in charge of conducting the plant
- **TYPE III** - Person in charge of maintenance / commissioning / decommissioning
- **TYPE IV** - Person in charge of integrity checks

The Certification is valid for 5 years. For the maintenance of the same, the continuity in the exercise of the activity must be documented to the certification body on an annual basis, or the participation in technical and / or regulatory refresher courses for a minimum of 6 hours each year.

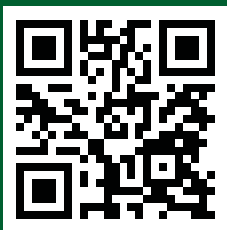
